Esteemed guests included Honorable State Minister, MOHFW, Mr Zahid Maleque, MP; Syed Monjurul Islam, Secretary MOHFW; Prof. Dr. Deen Mohd Noorul Huq, Director General, Directorate General of Health Services (DGHS); Md. Noor Hossain Talukder, Director General, Directorate General of Family Planning (DGFP); Dr. Md. Quamrul Islam, Director, IPHN and Line Director, NNS, and Chairperson, Board of Trustees of BBF, Dr S.K Roy. The ceremony was chaired by Syed Monjurul Islam, Secretary MOHFW.

This year World Alliance for Breastfeeding Action (WABA) has announced. The theme for WBW 2015 was -

“BREASTFEEDING AND WORK-LET’S MAKE IT WORK!”

Director, IPHN and Chairperson of BBF attended as guests on a BTV Talk Show, alongside the honorable Minister, MOHFW. The WBW theme message was sent to everyone in Bangladesh through mobile phone system. Like every year, World Breastfeeding Week was celebrated all over the Country by medical colleges and hospitals, different government and non government organizations, stakeholders and UN agencies, which organized seminars, workshops and nutrition fairs.

Mohammad Nasim MP, the Honorable Minister, Ministry of Health and Family Welfare (MOHFW) urged for creating breastfeeding corner in offices, industries, shopping malls, airports and factories to ensure that the mothers can breast feeding to their babies whenever they need. They should not wait for an Act or regulation in this regard for the greater interest of children.

Key Highlights (July- September 2015)

ACF activities in improvement of SAM Management

To facilitate improvement of SAM management, ACF, IPHN/NNS and UNICEF came together with an eight-months long capacity strengthening project titled “Strengthening Capacities on Management of Severe Acute Malnutrition in Government Health Facilities” (1st October 2014 – 30th June 2015). Under this project, trainings were conducted at 102 government health facilities out of total 484 government health facilities in Bangladesh from January to June 2015.

The following are the key achievements from the above – mentioned activities:

- Modality/Approach of training was well accepted by hospitals which were practical facility based training contrary to traditional class room teaching;
- Total number of trained government hospitals: 102 (54 District hospitals & 48 Sub district hospitals);
- Total number of trained government health staffs: 1,015 from Jan – Jun 2015.
- 100% of the targeted facilities now have the capacity to provide SAM management as per the existing national guideline on severe malnutrition;
- 31% of trained facilities have already been functional in identifying and treating these vulnerable cases;
- 71 % of trained health facilities have started regular reporting every month.

Meeting of Partners forum for Nutrition (PFN)

6th quarterly Partners Forum for Nutrition (PFN) meeting was held on 8 September 2015 at IPHN Conference Room with various stakeholders and partners of NNS. The meeting was held to share and discuss the partner supported nutrition activities, harmonize strategies and identify gaps. Dr. Md. Moudud Hossain, Program Manager, NNS initiated the discussion. He narrated the background and objectives of formation of this forum. He emphasized all the NGOs working in nutrition to come forward under a MOU with NNS/IPHN. He discussed about the importance of MOU which includes the accountability and responsibility for both the MOU partners.

Participants from partner organizations [SPRING, BRAC University, Save the Children - TCM project, CARE Bangladesh] presented their organizational activities, performances, learnings and best practices. All the participants participated actively in the discussion session.

A total of 22 participants from 12 tea gardens received hands-on orientation on using the IPHN recommended record keeping and reporting formats. The orientation session was facilitated by Dr. Md. Training on IYCF in FY 2014-15

5 Days Training of Trainers:

Infant and Young Child Feeding (IYCF) is an important component of NNS. For improving IYCF practices, training of field level service providers is of utmost importance. To accomplish this, NNS provided ToT through ICMH, Matuail, Dhaka. Participants were UHFPO, UFPO, MO-PHN, MO, MO (MCH-FP), Sr/Jr. HEO etc. The duration of the ToT was of 5 days. A total of 238 participants received the training in 12 batches. Director, IPHN, Program Manager, NNS and Deputy Program Manager, NNS also participated as facilitators.

3 Days Field level Training:

NNS provided 3-days training at field level, at the Upazila Health Complexes to Class I (Doctors, UHFPO etc), Class II (SACMO, Nurses, AUFPO etc) and class III staff (HI, SI, AHI, FPI, HA, CHCP, Statistician, Medical technologist (EPI, Lab, X-Ray etc.), EPI, FWV, FWA, Pharmacist, LCA etc) of both health and family planning departments in batches. Each batch consisted of 30 participants. Civil Surgeons and DDFPs of 14 districts participated as non local resource persons in the training.

This training was conducted in 56 upazilas of 14 districts where 10,559 participants received the training in 351 batches.

Baby Friendly Hospital Initiative (BFHI)

National Nutrition Services (NNS) is working on revitalization of BFHI, in this context BBF had signed a MOU on 17 April 2012 to conduct 64 (conducted 29). Subsequently MoUs were also signed on 15 January 2014 to conduct 144 and 26 February 2015 to conduct 188 batches of training in hospitals and Upazila Health Complexes.

BFHI recognizes and awards birthing facilities who successfully implement the ten steps to successful breastfeeding and the international code of marketing of breast-milk substitutes.

Becoming a baby- friendly facility is a comprehensive detailed process. It includes a) 20-hour course (4 days) Training of the Trainers (ToT), b) 4 days BFHI training of the maternity staff of hospitals, c) formation of BFHI committee, d) practices 10 steps, e) external assessment of hospital practices and f) certification.

From 2012-2015, 361 (out of 499) health facilities have gone through the revitalization process. The participants were 4,290 overall in three years. 293 upazilla health complexes (UHCs) and 68 medical college hospitals (MCHs) received the training. 361 Breastfeeding Corners were established nationwide. Revitalization of BFHI strengthens the IYCF practices and principles and ensures child and maternal health.

4. Dedicated IPHN team working regular and its workflow is going smoothly

BCC Team Meeting at IPHN/NNS

IPHN considering the level of effort needed to accomplish BCC related activities listed in the NNS OP formed a BCC team on February 03, 2015. The BKMI arranged and facilitated 2nd BCC Team meeting on 4th August, 2015 at Institute of Public Health Nutrition (IPHN). Dr. Tapan Kumar Biswas, Deputy Director, IPHN and Program Manager, NNS, Mohakhali, Dhaka presided over the meeting.

Recent activity of BCC team of IPHN:

1. Capacity Assessment Tool: Capacity Assessment Tool was understood by the team to assess capacity of the IPHN gained over the period time in terms of SBCC activities and Knowledge Management (KM) issue related to SBCC.
2. Progress review on Digital Archive at IPHN
3. Support in updating e-toolkit and provide expert opinion

Review and Develop BCC Materials and Messages related to Nutrition for Elderly people of Bangladesh

Considering the emerging demographic phenomenon of ageing in Bangladesh, NNS/IPHN organized a workshop entitled “Review and Develop BCC Materials and Messages Related to Nutrition for elderly people of Bangladesh” on Wednesday 22 April to Thursday 23 April, 2015.

It is important to develop effective BCC program including BCC materials and messages on geriatric nutrition for better health for the elderly and to address the complicated context related to elderly people’s nutrition. It is expected that the information gained will be of use in raising awareness on special nutrition needs and healthy food in this important and growing sector and provide a useful resource for policy-makers and planners to ensure social security, health care, employment and rehabilitation for older people of Bangladesh.

Considering the importance of a flip chart on nutrition messages, NNS organized two days workshop on “Review and Develop Flip Chart as BCC Tool related to Nutrition” organized by National Nutrition Services (NNS), IPHN. A workshop was held on Wednesday 1 April to Thursday 2 April, 2015 at the IPHN Conference Room, Mohakhali, Dhaka.

Different organizations shared their existing flip charts including ASA, IEM unit, SHIKHA project, BRAC, DSK, and UNDP. There was discussion on selecting thematic areas. Three different groups worked on the six thematic areas and were presented. They were IYCF, GMP, ECD, adolescent and maternal nutrition, basic nutrition and food Safety & hygiene promotion.

National Nutrition Policy 2015

The Cabinet of Bangladesh gave endorsement to National Nutrition Policy 2015. It was our dream, hard work and kind participation which led us to this day. Thank you all for being there and for supporting Bangladesh Nutrition.

The Cabinet has consented to the draft of the national nutrition policy that aims to ensure nutrition for mothers, children, adolescent girls and the poor people.

Basically, the nutrition policy’s objective is to facilitate availability better nutritious food to remove the malnutrition, particularly mothers, adolescent girls, children and the deprived and to improve the quality of lives to expedite national development.”

On-the-job training by DNSO to frontline health and family planning workers

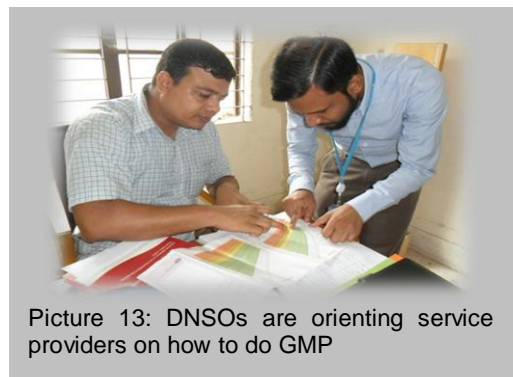
On-the-job training (OJT) is the training by which employee is trained at the place of work while he or she is doing the actual job. OJT allows employees to learn by actually performing a specific job or task. District Nutrition Support Officer (DNSO), one per district are currently working in 43 districts with district and sub-district management teams for nutrition mainstreaming into the health and other sectors.

DNSOs are performing OJT as a part of their day to day job on different topics related to Direct Nutrition Interventions (DNIs) and Nutrition Sensitive Interventions (NSIs) to increase skills of frontline health and family planning workers. Common topics are: IYCF, growth monitoring and promotion (GMP); anthropometric measurement; nutrition counseling; record keeping using tally sheet and register book; online reporting etc.

Till date around 16,500 health and family planning workers benefited from the OJT conducted by DNSOs in all 43 districts. That is reflected in the increase in the online reporting of nutrition indicators reported in the DHIS-2 system.

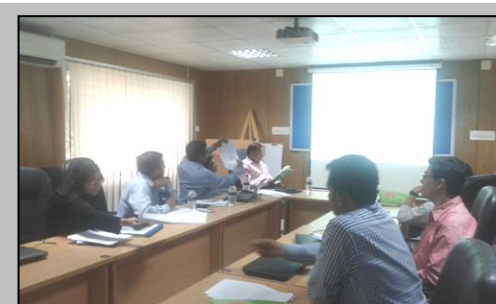


Picture 13: DNSOs are orienting service providers on how to do GMP

Follow-up workshop on ‘Harmonizing Nutrition Information System among NGOs working on Nutrition

A workshop was organized at a Hotel in Dhaka on 2-3 October, 2015 to discuss on mapping of nutrition indicators and to review and collect feedback on draft harmonized reporting format for nutrition interventions among NGOs. Many of partner NGOs involved in nutrition program implementation participated in the workshop which included Save the Children, Plan International, World Vision, Care Bangladesh, FHI360, RADDa, MI and others. Director and Program Managers of NNS, Program Manager of MIS-DGHS and other experts of NNS also participated in the workshop. Director of NNS, Dr. Md. Quamrul Islam and PM of NNS, Dr. Md. Moudud Hossain made opening remarks focusing on the importance of this workshop and harmonized reporting formats. There were a total of 32 participants in the workshop representing different NGOs working on nutrition in Bangladesh and the relevant NNS officials.

Currently there is intermittent flow of information on nutrition program performance from NGOs which resulted in lack of data, duplication of efforts and inefficient distribution of resources among different geographic areas in the country. Aweke Teklu, DFID consultant made presentation on mapping of nutrition indicators among NGO implementation areas which was followed by Dr Shahrear’s presentation on draft harmonized reporting formats. Large and small groups discussions held in each section on reporting format. The next step after this workshop will be to incorporate all those comments provided during the workshop and make a final review with Program Manager, then upload it on MIS website and conduct orientation

Workshop to Update BMS Code/Act Monitoring Checklist

A workshop to update the existing BMS code/Act monitoring checklist was held on 16 September 2015 at IPHN Conference Room. The participants from IPHN, NNS, BBF and MNH were present in the workshop. The main objective of the workshop was to discuss about the existing “BMS Code Monitoring Checklist” which was used by BBF and to update the monitoring checklist according BMS Act 2013. A nine member committee was formed to draft the updated monitoring checklist.

NTG Follow-up meeting

A Meeting on “Follow-up of decisions of NTG meeting” was held on 10 August 2015 at IPHN Conference Room. During the meeting, Dr. Md. Quamrul Islam, Director, IPHN and Line Director, NNS welcomed the participants and talked about agendas of the meeting. Then he requested Dr. Nasreen Khan, (OSD, DGHS, Attached as Technical Support on Nutrition, Public Health & WHO Wing, MoHFW) to facilitate the meeting. Dr. Mohsin Ali, Nutrition Specialist, UNICEF Bangladesh briefed on issues around IFA supplementation including national requirement, the target group of consuming IFA tablet, compliance of the national IFA status and its coverage. He also mentioned about the supply gap issue of IFA tablets.

Dr. Md. Yunus, DPM, IMCI shared their provision of procurement of IFA according to their Operational Plan (OP). Dr. Quazi Hefayet Hossain, DPM, CBHC mentioned about their last procurement status of IFA tablets in the last year. He also shared their plan of procurement of IFA for the year 2015-16. After that, Dr. Md. Mustafizur Rahman, Country Director, MI recommended that planning and procurement should be conducted by NNS/IPHN otherwise it is difficult to coordinate. On the other hand, Dr. Shimul Koli Hossain, Programme Manager, MCH Services Unit, DGFP shared that they have no plan to procure IFA for children. They only purchase IFA for reduction of anemia. In addition, Dr. K.M Azad, DPM, NNS suggested Ferrous Fumarate instead of Ferrous Sulfate, as it is more digestible and has no side effect.

Dr. Tapan Kumar Biswas, Deputy Director, IPHN and Program Manager, NNS talked about their plan for adolescent regarding IFA. After that Dr. A.M Zakir Hussain, Senior Advisor, NIPU, NNS discussed in brief on different issues raised in the meeting. He recommended some suggestions to minimize the gap for procurement and distribution of IFA.

Then Dr. Mohammad Shahrear Farid, Consultant (M&E), NNS shared a monitoring checklist on nutrition activities for all types of facilities and asked for feedback on checklist (if any). Finally, respected chair concluded the meeting with a vote of thanks.

11th NICC Meeting

The 11th meeting of Nutrition Implementation Coordination Committee (NICC) was held on 15 September, 2015 at IPHN Conference Room. At first, Director, IPHN and Line Director NNS informed about the objectives of this meeting. The agenda were adoption of meeting minutes of previous meeting; assess the progress of NNS activities, implementation of DAAR indicators, status update of National Vitamin-A Campaign 2015 and review of activities of relevant OPs on Nutrition Implementation etc.

Dr. Md. Moudud Hossain, Program Manager, NNS presented and shared the information according to the agenda. The Program Manager mentioned the progress of NNS activities regarding BCC coverage, HR development, National Vitamin 'A' Campaign, community and facility based management of severe & moderate acute malnutrition, IYCF, food fortification, food safety, M&E, Nutrition Surveillance Program, establishment of nutrition units, etc.

Moreover, progresses on OP level Indicators were also discussed in the meeting. Program manager also showed the coverage of training progress during FY 2014-15. He also discussed about the update of National Vitamin-A Campaign 2015 and its coverage.

Monitoring Visit

Dr. Md. Moudud Hossain, Deputy Director, DGHS and Program Manager, NNS along with Dr. Nasreen Khan, (OSD, DGHS, attached as technical Support on Nutrition, Public Health & WHO Wing, MOHFW) and Dr. Md. Moinul Haque, Planning Specialist, NNS/IPHN visited Nilphamari and Dinajpur districts to observe and monitor the service delivery, recording and reporting, logistics management of the various service delivery centers from 21-23 September 2015.

The team visited to Bahagili Dangarhat Community Clinic (CC) of Kishoreganj upazila, IMCI & Nutrition Corner of Kishoreganj upazila Health Complexes (UHC), Khutamar Family & Welfare Centre (FWC) of Jaldhaka upazila and IMCI & Nutrition Corner & SAM unit of Nilphamari General Hospital on 21 September 2015.

On 22 September 2015, the team visited IMCI & Nutrition Corner of Birol UHC, Nashratpur FWC and Sannyashdanga CC of Chirirbandar upazila and IMCI & Nutrition Corner of Dinajpur General Hospital.

The team provided on-job training of record keeping and reporting and suggestions to the relevant service providers and district and upazilla level health authority and reporting for better service deliveries.

Popular Folk Media Campaign- PUSTI PALA in Tea Garden

Kulaura, one of the biggest tea garden surrounded upazilas of North-east part of Bangladesh under Moulvibazar district witnessed a popular folk media campaign through the musical drama show, named 'PUSTI PALA in Tea Garden', was organized by Kulaura Upazila Health Complex supported by Tackling Childhood Malnutrition project of Save the Children and NNS/IPHN, from August to October 2015. A renowned theatre group of Moulvibazar, "Sobuj Bangla Theatre" performed in the musical drama show. The musical drama was shown in a total of twenty six spots of tea gardens under the upazila.

Tea garden worker communities are not aware and are not in practice of exclusive breast feeding, infant and young child feeding along with their health and hygiene practices. The musical drama show includes health and nutrition information, focusing those issues for raising awareness of the unprivileged tea garden community. The musical drama show was performed following the "PUSTI PALA" developed by NNS.

"This is first time I have seen a drama ever on nutrition in our tea garden" commented a mother- Alomoni Pasi from the audience of the drama show at Merina Tea Estate on last 4 September, 2015. She is a garden worker, also exclaimed that how the play showed interesting messages on breast milk, feeding practices and hand washing culture. She also expressed that it would be very useful to her family and relatives".

COVERAGE OF NUTRITION SERVICES

Nutrition Services from IMCI-N corners

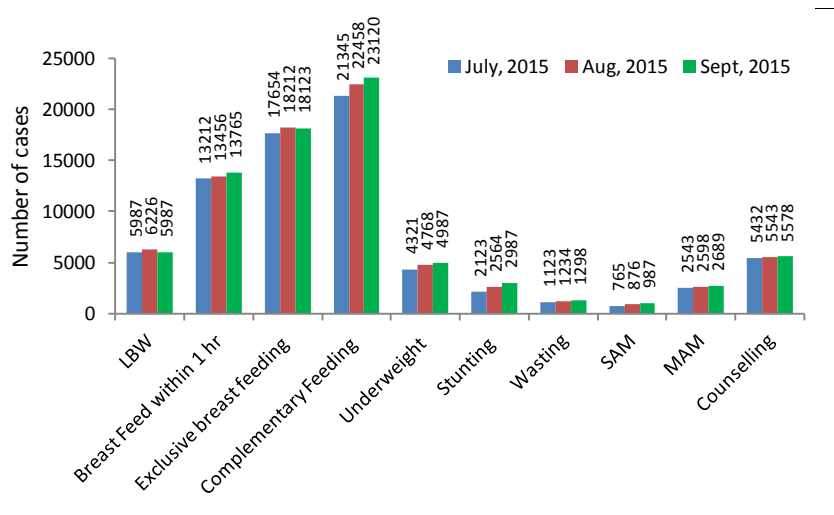
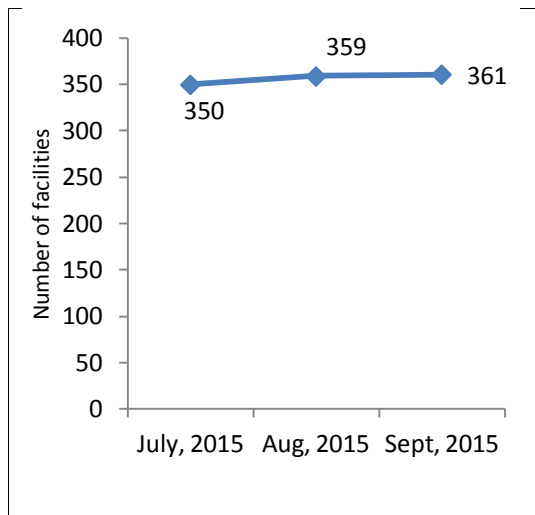


Figure 1: Monthly online reporting status from IMCI & Nutrition corners (July –Sept 2015)

Figure 1 shows the online reporting status of IMCI & Nutrition corners from July-September 2015, compiled by HMIS software. Currently almost 360 IMCI & Nutrition Corners from upazila and district levels are reporting on nutrition related indicators through online HMIS software. In September 2015, online reporting came from 361 IMCI & Nutrition corners including nutrition service data.

In July, the number of reporting was little bit lower as 350 as increase the Nutrition intervention of NNS. Figure 2 shows, the graphs of provided services from the IMCI & Nutrition corners from July-September 2015. The graph shows that IYCF practices have been increasing in the last three reporting months.

Monthly Progress Report On IMCI-N Corners

Nutrition Services from SAM units

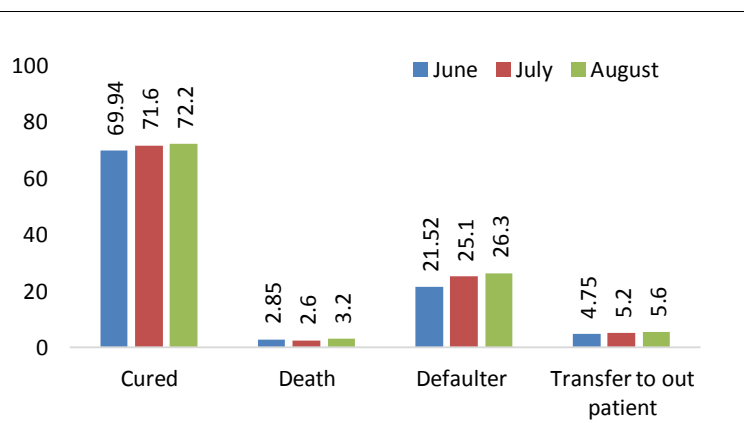
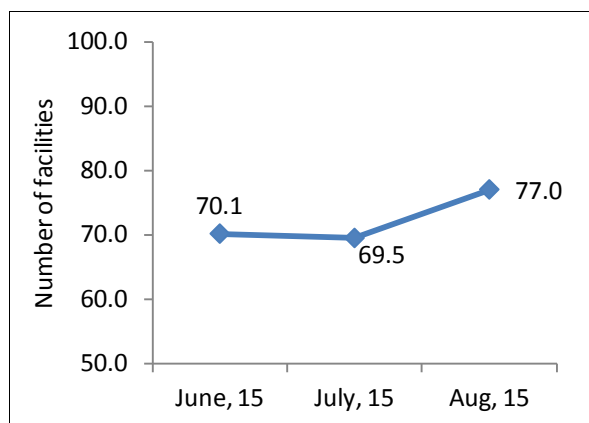


Figure 3: Percentage of received report from SAM Units by months (June –Aug 2015)

Figure 3 shows the Percentage of SAM facilities which provided SAM information in June – August 2015. These facilities have been providing reports to IPHN through e-mail or postal services. It is shown that the reporting rate, August is higher (77%) than the month of July 2015.

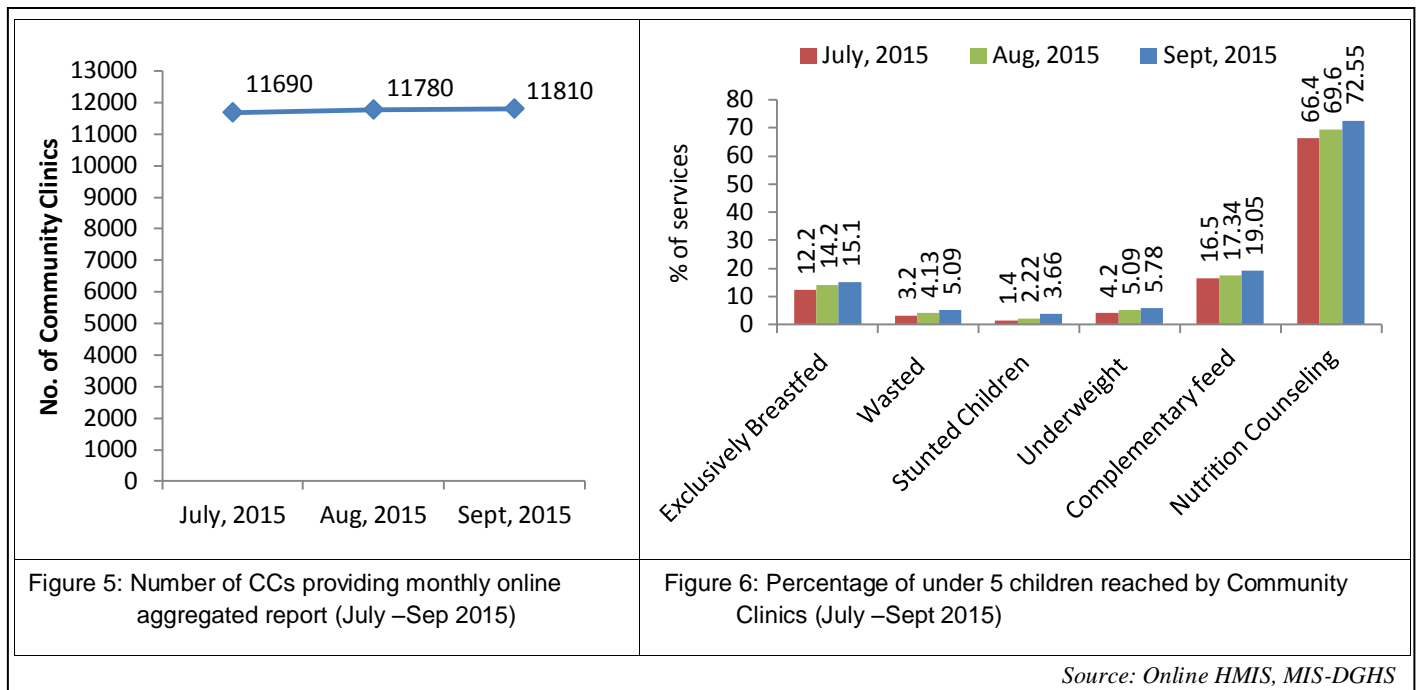
Figure 4: Percentage of SAM patients according to the discharged type by months (June –Aug 2015)

Figure 4 shows the status of discharged patients from different SAM units in those months. Among these, the Cure-Rate of August is higher (72%) than those in the month of June. On the other hand, defaulter rates are also higher than transferred or referred patients. It may be a reflection of the management of severe acute malnutrition the relevant SAM units which might have been improving with time.

Nutrition Services from Community Clinic

Figure 5 shows, the number of community clinics sending aggregated online reports from July-September 2015 through HMIS data management software DHIS2. The figure shows the reporting tendency is increasing day by day. At present the reporting has increased more than 11,500 Community Clinics which are reporting through online every month.

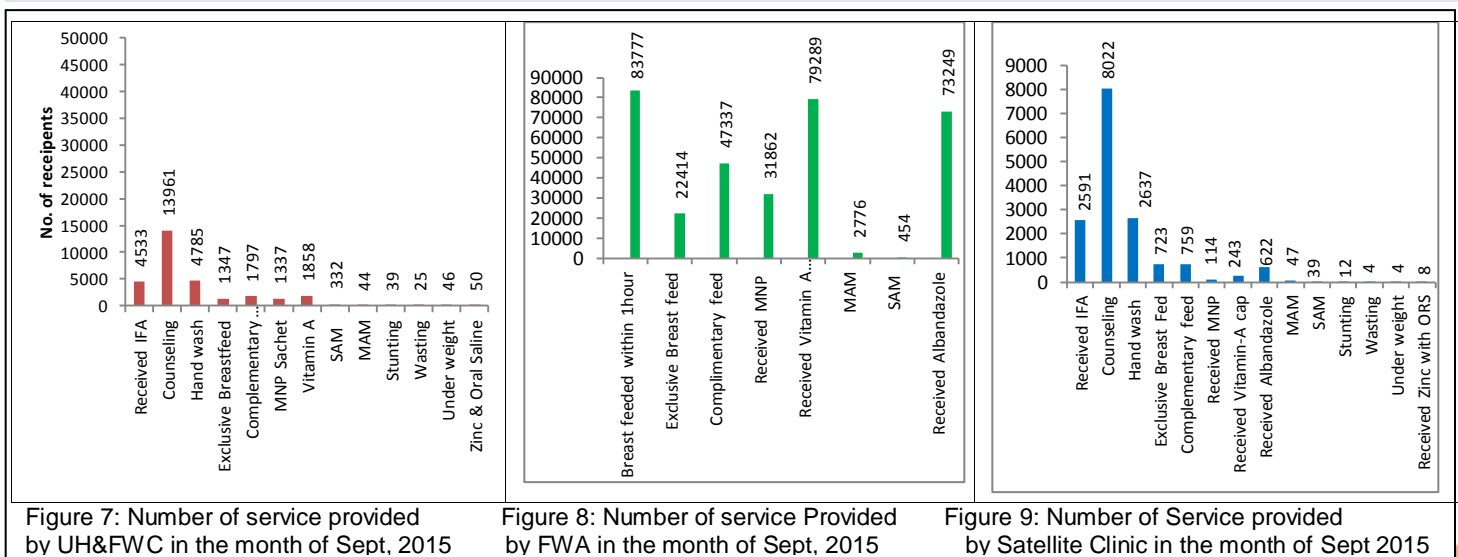
Figure 6 shows the graphs of services provided in Community Clinics from July-September 2015 collected from online HMIS software. The graph shows that the IYCF practice and counseling have been increasing in the last 3 months (July-September, 2015) in Community Clinics.



DGFP Reporting and Service Status

Figure 7 shows, the number of services provided in the UH&FWC in the last reporting month, collected from DG-Family Planning, through its online information system. In this graph, counseling is comparatively high.

Figure 8 shows the graphs of services provided by FWAs showing IYCF practice which has been increasing gradually in the month of September. Figure 9, describes the nutrition related services provided in Satellite Clinics in the reporting month.
